

# Site Safety, Security, General Rules and Registration

**These measures are in place for the safety and benefit of everyone using this site and apply to everyone entering site – NO EXCEPTIONS.**

**Make yourself aware of the Life Buoy locations around all three lakes**

**KHV PREVENTION – THIS SITE IS CLEAN – LET’S KEEP IT THAT WAY. NO NETS, MATS OR WEIGH SLINGS ARE TO BE BROUGHT ONTO SITE – STARCARR LAKES PROVIDES ALL NETS AND MATS**

- 1. Entry points onto site are covered by CCTV. All VISITORS must sign in** and register before leaving the carpark so we know who is on site and where they are located. Compulsory registration includes the date, time, name, address, car registration peg number (tag number for trout anglers) and EA licence number. All persons fishing will have licences checked on the bank. On leaving site you must also sign out with your departure time.
- 2. All coarse anglers must fill out the entry sheet in full in the registration hut on arrival**, identify the peg number they will fish, place the numbered red tag on the pond map in the appropriate peg so at a glance we who and know who and where you are. If you move pegs move your tag. Do not move other tags and please remove your tag when signing out so we know you have left the water. **Fly anglers registration** is a similar process to coarse but as this is a roving discipline select a yellow tag (numbered 1-16 bank & 17-20 boat) from the line of tags on hooks positioned below the Trout Lake map and marked “positions available”. Move this tag to the line of hooks above the Trout lake map marked “positions occupied”. Your selected number also needs to be recorded on the register as you sign in and on the catch returns form. When you leave site move the yellow tag back to its bottom hook marked “positions available” so we know you have left site and that space is now available. There are 20 pegs on the Trout lake, a maximum of 16 bank anglers and 4 boat anglers (2 boats ) at any one time
- 3. Permit payments must be made in full before fishing.** Place the money in the envelope, write your name and peg number on the front of the envelope and post it in the safe provided. If you do not have the correct change when you register, make an overpayment in the envelope and the change will be issued to you at the peg when licences are checked. **Be aware,**

**anyone found fishing who has not registered and paid in full will be charged DOUBLE on the bank - please note the registration process inside the hut is covered by the CCTV.**

4. Pegs/positions can be pre-booked a min of 24 hrs in advance at no additional cost, anyone who books a peg/position or boat and fails to turn up to fish and does not cancel before the booked will not be able to pre book again

5. **All anglers must be in possession of an EA National Rod Licence** and 2 licences are required for anglers using 3 rods. Site checks will be made by the bailiff and anglers not in possession of their licence will be asked to leave and their details passed onto the relevant authorities.

6. **Strictly NO alcohol** allowed on the site - anyone found under the influence of alcohol or consuming alcohol on the site will be asked to leave.

7. No wading, swimming or entering the water for any reason. **No cooking, No fires, No camping stoves, No guns or weapons of any description** – bait catapults only.

8. **No children under 15 allowed on the site unless accompanied by an adult at ALL TIMES.**

9. No dogs, no excessive noise or loud buzzers, no hammers, no mallets and no radios (unless used with ear phones)

10. No litter to be left on site at all – if you bring it here, then you take it home.

11. Do not disturb any of the wildlife, fauna or flora. **Swan Mussels are in all 3 lakes – do not touch them.**

12. **Toilets facilities are on site, please use them**, respect them and leave them as you expect to find them and remember to take out all baited hooks before leaving your peg for the toilet

13. Do not climb up trees; do not climb over fences or over locked gates. Do not wander into restricted areas, stay on the foot paths, only fish designated pegs and where pegs are signposted as closed or taped off do not use them.

14. **By signing in you are agreeing to comply with the Site Safety Rules and also the fishing rules specific to each lake.**

**Copies are available at the point of registration.** The rules are in place for the safety and benefit of everyone using the site and for the health and welfare of the fish and wildlife. **Anyone in breach of these site rules will be asked to leave the site. No refunds will be given.**
